#### President's Updates: Lynne Warne

#### President-Elect: Claudia Weber

Christmas presents for retired sisters:

Visits will be on Friday, December 16. Sisters of Mercy will be at 10 am, Dominican Sisters at 2 pm. Members can bring cash, notecards or stamps for gifts for the sisters.
BOD 2023 – 2025: The Board of Directors slate for 2023-25 should be presented at the February 4 Board meeting. Claudia is asking the current board to 1) send her a narrative of what your responsibilities have been in your current position and 2) indicate to her if you are willing to continue to serve in your current position or any other position.

• Officers on the Board shall consist of President, President-Elect, Programs Chair, Secretary, Communications Chair, and Treasurer (these positions are voted on by the membership at the March membership meeting) and Parliamentarian, which is appointed by the President. Other participants are committee chairs.

#### Parliamentarian: Cindy Zwickel

- By-laws are being changed to reflect our new mission, vision and operating statements. Cindy stresses that the bylaws need to be flexible enough so we don't have to keep changing them.
- Cindy has sent the updated bylaws to current Board members. All BOD members need to review, edit and provide feedback to Cindy before year end, ensuring it reflects the way the NCBWL operates.

## Spiritual Life: Cheryl Pryor

- Will work on setting up an Advent Zoom. Cheryl will ask member Jennie Guinn to lead it, and the NCBWL will compensate Jennie for her work.
- Fr. Michael O'Bryan's retirement: Lynne Warne asked the Nashville Diocese on 10.25.22 for a replacement for Fr. O'Bryan. Claudia offered to follow up with Hans Toecker, Director of Clergy and Pastoral Support for the Diocese. Discussion ensued about requesting a young priest or deacon to serve as our next spiritual advisor.

### Membership: Kim Hoover

• Kim submitted the membership report (attached), with a total of 113 paid and honorary members. "Silver" members are those that have had 25 years of uninterrupted membership. "Honorary" members are over 80 years of age; they are free unless they want to pay annual dues.

#### Treasurer: Deb Fay

- Financial report attached. Pearls of Wisdom 2022 set a new fundraising record for the NCBWL. As a result, we are giving \$20,000 to each of the three Catholic high schools, with another \$5,000 set aside for the new St. Michael's Academy.
- We have a healthy checkbook balance of \$14,152.27.

- Here's a financial snapshot of the fundraiser, per Deb:
  - Total Revenue = \$89,399 Total Expenses = \$26,433 Net to distribute = \$62,965

  - Total attendees: 128 (130 meals paid for)
  - Breakdown of attendees: 62 members / 66 guests
  - Three sponsors had no attendees: WTC, Hermitage Hills, and Star PT
  - Two sponsors filled some of their seats: Patricia Vance filled 2 seats and Donna Adams filled 6 seats
  - Lisa Link and Nikki Moreland suggest that we start an on-going mentoring program for the students we support.
